Adult Services Program - Homeward Bound serves single adults experiencing homelessness through residential programs that range from the only year-round emergency shelters in Marin County to permanent supportive housing. In the past year, our agency served 936 adults, including 88 military veterans. Homeward Bound's array of housing options paired with social services such as counseling, educational support, and financial literacy training, helped to ensure last year that 88% of adults in our programs exited for housing opportunities.

4b (Code:) (Expenses \$ 1,353,027. including grants of \$) (Revenue \$)

Family Services - Since 1974, Homeward Bound has operated the only year-round emergency shelter for homeless families in Marin County, California. Last year, Homeward Bound served a total of 80 families through shelter, housing, and robust case management to help them end homelessness in their lives and move home for good. This included 125 children ranging in age from newborns to teens. 81% of all families who exited our programs in the past year left for housing opportunities.

Mental Health Services - Homeward Bound provides emergency shelter and permanent supportive housing for adults suffering from persistent mental illness. These programs and services focus on enhancing individual strengths. Benefits of care and treatment include remission of symptoms, stabilization, and participation in regular life activities through part-time work, volunteerism, and peer counseling.
